**ALCOHOLIC BEVERAGE PERMIT**

City of Conroe, Code of Ordinances  
Article II, Chapter 18, Section 31-33

- A. Applicant is required by the City to have a state (TABC) license before a city license can be issued.
- B. Applicant must show proof of their state (TABC) license.
- C. Fee for the city alcoholic beverage permit is one half (1/2) the amount of the state (TABC) fee.

**PERMIT:** A permit by the city will be issued upon the presentation of the state license and the payment of fees at that time.

**RENEWAL:** All permits shall be renewed on a bi-annually bases (every 2 years).
